Housing search tools

- **Arizona public housing authority list** – There are 24 Public Housing Authorities (PHAs) in Arizona. PHA's administers Housing and Urban Development (HUD) housing programs including Housing Choice Vouchers (Section 8) and project-based voucher programs which provide subsidies to units of a particular housing developments
- **HUD resource locator tool** – This tool helps you find affordable and income-based housing opportunities, nearby HUD offices, local public housing authority agencies (PHA), homeless resources, as well as affordable, elderly and special needs housing
- **ADOH housing search tool** – Explore a variety of housing options in Arizona that cater to your needs and budget, including market-rate rentals, affordable housing, accessible units and specialized housing for seniors and veterans. This service is free to use.

Arizona Health Care Cost Containment System housing program

Behavioral health providers can submit Arizona Health Care Cost Containment System (AHCCCS) housing program applications to the AHCCCS Housing Administrator by completing the following steps:



Arizona Health Care Cost Containment System housing program (cont.)

1. Submit application [online](#)
2. Receive notification that application was received
3. Receive notification that we placed the patient on the AHCCCS housing program waitlist
4. The member and their clinical team will be notified when the member's name reaches the top of the waitlist

AHCCCS prioritizes individuals on the AHCCCS Housing Program waitlist based on a combination of clinical needs, housing status and social vulnerability factors.
