# STAR Kids, STAR Health, STAR+PLUS, MMPs: Notice of STAR+PLUS Handbook Revision 25-3 and Clinical Guides

#### **Background for STAR+PLUS Handbook Revisions:**

The STAR+PLUS Handbook contains HHSC-approved policies and procedures related to the STAR+PLUS Program. The Texas Health and Human Services Commission (HHSC) periodically updates the Handbook to reflect policy changes. HHSC informs STAR+PLUS managed care organizations (MCOs) and Medicare-Medicaid Plans (MMPs) of these updates before publication.

#### **Background for Clinical Guides:**

The Patient Driven Payment Model Long-Term Care (PDPM LTC) will replace the current Nursing Facility (NF) reimbursement model, the Resource Utilization Group (RUG), effective September 1, 2025. Due to federal requirements in <a href="Itile-42 Code of Federal Regulations">Title 42 Code of Federal Regulations (CFR) §441.302(e)</a> and (f), changing the NF reimbursement model from the RUG to the PDPM LTC requires HHSC to incorporate the PDPM LTC model into the cost limit methodologies for the NF waiver programs, Medically Dependent Children Program (MDCP) and STAR+PLUS Home and Community-Based Services (HCBS). Implementing the PDPM LTC model for MDCP and STAR+PLUS HCBS requires modifying the STAR Kids Screening and Assessment Instrument (SK-SAI) and STAR+PLUS Medical Necessity and Level of Care (MN/LOC) assessments to add the fields needed to calculate the PDPM LTC score.

#### **Key Details for STAR+PLUS Handbook Revisions:**

This notice informs MCOs and MMPs of STAR+PLUS Handbook revision 25-3, effective September 1, 2025. The revision updates several sections and forms. A summary of the changes is provided in the attached Revision Notice document.

#### **Key Details for Clinical Guides:**

HHSC updated the MN/LOC Item-by-Item Guide and SK-SAI Service Coordinator Manual (clinical guides) to reflect the change from RUG to PDPM LTC.
