This enhancement addresses the following PT/OT/ST and Nursing home health HCPCS with a CMS Status Indicator of E, I or X: G0299, G0300, G0490, G0493-G0496, G0529, G2168, G2169, S0274, T1030, T1031, T1002, T1003, T1021. These HCPCS codes will not be considered for reimbursement when submitted by physicians and physician groups. These HCPCS codes will be considered for reimbursement when appropriately submitted by home health providers.
