## Take Note

### Implementation Delay: Remote Physiologic Monitoring (RPM)

The Medical Policy titled *Remote Physiologic Monitoring (RPM) (for New Mexico Only)* will not be effective on Jan. 1, 2026, as previously announced; implementation of the new policy has been postponed until further notice.

### Implementation of Revisions Postponed: Computer-Assisted Surgical Navigation for Musculoskeletal Procedures

The Medical Policy titled *Computer-Assisted Surgical Navigation for Musculoskeletal Procedures (for New Mexico Only)* will not be revised on Feb. 1, 2026, as previously announced. An existing policy has been replaced with a new or different policy

### *Retired*

The health service(s) addressed in the policy are no longer being managed or are considered to be proven/medically necessary and are therefore not excluded as unproven/not medically necessary services, unless coverage guidelines or criteria are otherwise documented in another policy
