### Implementation Cancelled: Niktimvo™ (Axatilimab-Csfr) (for Indiana Only)

The new Medical Benefit Drug Policy titled *Niktimvo™ (Axatilimab-Csfr) (for Indiana Only)* will not be implemented on **May 1, 2025**, as previously announced. This drug will not be managed by UnitedHealthcare Community Plan of Indiana at this time.

### *Revised*

An existing policy has been reviewed and revisions have been made to the clinical coverage criteria

### *Replaced*

An existing policy has been replaced with a new or different policy

### *Retired*

The health service(s) addressed in the policy are no longer being managed or are considered to be proven/medically necessary and are therefore not excluded as unproven/not medically necessary services, unless coverage guidelines or criteria are otherwise documented in another policy
