**1. Background:**

Livdelzi (seladelpar) is a peroxisome proliferator-activated receptor (PPAR)-delta agonist indicated for the treatment of primary biliary cholangitis (PBC) in combination with ursodeoxycholic acid (UDCA) in adults who have an inadequate response to UDCA, or as monotherapy in patients unable to tolerate UDCA.

This indication is approved under accelerated approval based on a reduction of alkaline phosphatase (ALP). Improvement in survival or prevention of liver decompensation events have not been demonstrated. Continued approval for this indication may be contingent upon verification and description of clinical benefit in confirmatory trial(s).<sup>1</sup>

**2. Coverage Criteria<sup>a</sup>:**

**A. Initial Authorization**

1. **Livdelzi** will be approved based on **all** of the following criteria:

a. Diagnosis of primary biliary cholangitis

-AND-

b. Patient does not have decompensated cirrhosis

-AND-

c. **One** of the following<sup>^</sup>:

(1) **Both** of the following:

(a) Used in combination with ursodeoxycholic acid (e.g., Urso, ursodiol)

(b) Patient has failed to achieve an alkaline phosphatase (ALP) level of less than 1.67 times the upper limit of normal after at least 12 consecutive months of treatment with ursodeoxycholic acid (e.g., Urso, ursodiol)

-OR-

(2) History of contraindication or intolerance to ursodeoxycholic acid (e.g., Urso, ursodiol)

-AND-

- d. Patient is not receiving Livdelzi in combination with Iqirvo (elafibranor) or Ocaliva (obeticholic acid)

-AND-

- e. Prescribed by one of the following:

- (1) Hepatologist
- (2) Gastroenterologist

**Initial authorization will be issued for 12 months**

### **B. Reauthorization**

1. **Livdelzi** will be approved based on **all** the following criteria:

- a. Submission of medical records (e.g., laboratory values) documenting a reduction in ALP level from pre-treatment baseline (i.e., prior to Livdelzi therapy)

-AND-

- b. Patient does not have decompensated cirrhosis

-AND-

- c. Patient is not receiving Livdelzi in combination with Iqirvo (elafibranor) or Ocaliva (obeticholic acid)

-AND-

- d. Prescribed by one of the following:

- (1) Hepatologist
- (2) Gastroenterologist

**Reauthorization will be issued for 12 months**

### **3. Additional Clinical Rules:**

- Supply limits may be in place.
- Notwithstanding Coverage Criteria, UnitedHealthcare may approve initial and re-authorization based solely on previous claim/medication history, diagnosis codes (ICD-10)

and/or claim logic. Use of automated approval and re-approval processes varies by program and/or therapeutic class.
